## **Emergency Contacts**

Mel O'Day has a valuable lesson to share with you. Mel's house caught fire while she was out of town over the Christmas holiday. Because she had shared her emergency contacts with the "keeper of the list" in our neighborhood as well as with her neighbor, the police had the information they needed to contact Mel and her family. We have also had emergencies when neighbors did not answer the door or when families couldn't reach their loved ones at the Downs. Please make sure you have completed and returned your Emergency Contacts form, and please do so **each year**. Several of the forms in our file are either incomplete or more than 5 years old. To make sure friends and families can be reached in an emergency, your board will make sure that each neighborhood representative has a scanned copy of the emergency contacts and will work to make sure all contacts are up to date.

Also, please consider sharing this information with a trusted neighbor. And if your garage or outside door(s) has a keypad, share that keypad code with your neighbor. Let's all work to keep each other safe!

#### **Woodland Walk Bridge**

Work on the bridge is postponed until we evaluate bank erosion from the last big rain.

#### Yard Waste at Bayberry Site

Please tell your contractor that he is **NOT** allowed to put yard waste from yards in Clemson Downs on the Bayberry site. We have had to ask 2 contractors in the last month to remove yard waste. Regulations state **self-generated yard waste** is allowed. That means if you cut it and you take it to the Bayberry site, it is acceptable. If the city of Clemson (they are the ones who pick up the yard waste) finds that we are allowing **all** contractors to put yard waste on the pile, we may lose our ability to use the Bayberry site. Then you will have to put yard waste in front of your house for pickup.
