- The budget for 2025 was approved. There is no increase in neighborhood dues but is an
  increase in Community Cable TV from \$408 for the year to \$480. This payment is due when
  dues are paid in January and is for the entire year with no refund if the subscriber withdraws
  before the end of 2024.
- The board officers, committee chairs, and board representatives will be introduced in the February 2024 *Communicator*.

FYI: For those of you who may be unaware, the ARC is a sub-committee of the POA Board. We can only recommend applications. They then must be presented to the entire Board, which meets January 9, for final approval. Your approved application will then be returned to you, and your project can begin. #### **Community Cable TV News**

Over the past three years, the annual CCTV Fee collected by CDPOA has remained constant at \$408 (\$34 per month per subscriber). Unfortunately, like the inflation we have seen in 2023, the annual fee will increase to \$480 (\$40 per month per subscriber) in 2024 to align with the Association's cost. This remains an incredible bargain considering the unparalleled entertainment bundle we receive. Our partnership with Vyve Broadband secures access to approximately 72 cable television networks, with 31 of them broadcasting in stunning High Definition.

Even with this adjustment, CCTV continues to be an outstanding deal. Compared to similar packages available to our neighbors, our subscribers enjoy savings of up to \$150 per month! This represents an incredible opportunity to access top-quality entertainment at an unbeatable price point.

As in prior years, your annual CDPOA Membership Fee statement will include the option to renew your subscription for 2024, ensuring uninterrupted access to this exceptional entertainment package.

#### **FYI**—For Your Information

#### Hose faucet covers

While we haven't yet had the cold temperatures of last year (remember when it was 7 degrees on Christmas Eve last year?) we could certainly get below freezing. Don't forget to cover your outside faucets to prevent damage.

#### **Sprinkler systems**

Another winter water warning—please make sure you have turned off your sprinkler system for the winter. When sprinklers run in the winter, the overspray can cause black ice that could easily cause skidding for cars and walkers.
