New Phone Number Format

When you get your new directory, you will notice something a little different about the telephone number listings. The Public Service Commission of South Carolina has created a new area code



(821) for the upstate of South Carolina. This new 821 area code will cover the same geographic area as the current 864 area code but will only affect **new** telephone numbers. All **existing** South Carolina customers will retain their area code and will not need to change telephone numbers. However, beginning in June 2024, everyone in the upstate will be required to dial all ten digits (area code plus the number) when calling within the area covered by the current 864 and new 821 area codes. Optional ten-digit dialing will be

enabled in January 2024, with mandatory ten-digit dialing beginning in June 2024.
